**NUTRIO® UNLOCK®** contains soil-enhancing bacteria manufactured from specifically selected pure strains of microbes, cultured in an oxygen-enriched process.

**NUTRIO UNLOCK** can be blended with conventional and organic fertilizers and soil amendments, injected through irrigation systems, and/or impregnated onto dry fertilizer. The specific selection of beneficial microbes in **NUTRIO UNLOCK** improves soil biodiversity and allows for enhanced nutrient mineralization in the soil. **NUTRIO UNLOCK** should be used as part of a comprehensive Total Nutrition System® for optimizing soil/nutrient conditions for plant growth, development, yield and quality.

# DIRECTIONS FOR USE

Recommended for all vegetable crops, small fruit, berries, citrus, bananas, tobacco, alfalfa, and all row (field) crops including, but not limited to cotton, sorghum, corn, wheat, sugarcane and soybeans.

**NUTRIO UNLOCK** can be blended with liquid fertilizers and soil amendments to be applied in ground application equipment and through fertigation equipment.

STARTER OR SIDE-DRESS: Apply 1-4 pints per acre.

**BROADCAST AND FERTIGATION:** Apply 2-4 quarts per acre in enough solution to provide thorough coverage. If sprayed on soil surface, then follow with an irrigation of at least ½ inch of water as soon as possible.

**MANURE APPLICATIONS:** 2-4 quarts per acre (2-4 quarts per 3,000-3,500 gallons of liquid manure).

**GOLF COURSES AND SPORTS TURF:** For fairways, tees and roughs, apply 1 quart per acre every 2-4 weeks as needed. For putting greens and problem areas, apply 1-2 quarts per acre every 2-4 weeks as needed. For post-seeding or over-seeding, apply 1-2 quarts per acre. For the first irrigation in the spring or

when Bermuda breaks dormancy, apply 1-2 quarts per acre. Following aeration apply 2 quarts per acre. **NUTRIO UNLOCK** should be metered into the irrigation system or if sprayed directly onto turf, follow with an irrigation preferably within 12-24 hours to incorporate the microbes into the root zone and maximize effectiveness.

**NURSERY:** Apply 2 gallons per acre 1-2 times, preferably in the spring, or as a soak, apply 16 fluid ounces per 100 gallons of water.

**TREE AND VINE ROOT DIP:** Prior to planting, dip bare roots into **NUTRIO UNLOCK**, either concentrate or diluted 1:1 with water, or spray onto roots in a 1:1 dilution with water.

NOTE: 1-2 quarts per acre is equivalent to 0.75-1.5 fluid ounces per 1,000 sq. ft.
